<u>President's Report - Ron Fernandes</u>

- Ron noted that Penny would like to highlight the increased communication from the board to members via email
- Ron reviewed the number police reports for the New Silver Beach area from this summer
- Ron noted the project that is being led by Beth Murphy which is working with the Town of Falmouth's Traffic Advisory Committee and Police Traffic Liaison on NSB traffic concerns.
- Started collecting and filing SBIA business and historical records into an electronic record-keeping system for better access to Board records.

<u>Treasurer's Report – Ron Fernandes</u>

- The two most significant revenue sources for our budget ... membership and store
- Membership budget for 2021 was 425 members. Actual was 487.
- Because of this, association brought in \$14,000 more than budgeted
- Extra funds were used to pay off the loan on the tennis court... paid off in four years when it was budgeted for ten years.
- \$33-34,000 cash balance by end of year which is an increase even with loan payment (see attached <u>2021 Profit/Loss Statement</u>).

Activities & Event Committee Report – Peter Leddy

- Peter gave a summary of 2021 Summer Activities and Events:
 - → Acknowledgement of volunteers and committee
 - → Acknowledgement to Penny for managing communication
 - → Tennis -- 60 kids! ... numbers were high this summer
 - → Kids' Bingo -- 5-6 bingo events ... 50 kids per event
 - → Kids' Korner (arts and crafts)
 - → Fishing and crabbing tournaments
 - → NSB's Got Talent ... 11 participants
 - → Sunday softball
 - → Illumination night
 - → Golf ... 28 participants which was the largest number ever
 - → Cornhole tournament
 - → Pickleball ... 52 players!
 - → NSB Gets Fit!

Beach Committee Report - Sarah Maxwell

 Sarah wrote a summary of the work from the beach committee, which was read by John Maxwell:

"I'd like to first thank our committee members, Carolyn Halloran and Allison Hutchins and our lifeguards, Carolyn, Emma, Lauren, Alyssa, Hannah, Cat and Sean. The lifeguards did a great job with swim lessons for 88 children and keeping the beach safe. The addition of water aerobics this summer was well attended and was a huge hit. Also, a big thank you to the grounds committee for coordinating the beach clean-up, which made a big difference. On another note, for the first time since I can remember we had some vandalism on the beach. We had three signs stolen and two red swim rescue buoys. We also had vandalism on the lifeguard stand. The guards made procedural changes to store items that were normally kept in the brown bins at the ends of each beach and were moved to the shed. We will have to replace the red floats for next summer."

Grounds & Harbor Committee Report – Andy Doherty

- Beach cleanup was done every other week this summer, so 4-5 times. The board will investigate cleaning weekly for next summer.
- Silver Beach Ave. lifeguard stand returned to its original location with much work with the town by Penny, Peter Lind and Andy
- Kayak racks used well but there are still boats still on the dunes... conservation does NOT want any boats on the dunes
- Dinghy racks will be going into the far corner of the harbor in next year or two
- Vandalism... ten signs either vandalized or stolen.
- Court looks good... reminder to not wear black soled shoes
- (Question from member) Why do we not use security cameras? Andy responded that the board can discuss this at the winter meeting.
- (Comment from member) Speeding continues to be a problem... younger children, stopping at stop signs. Police our own families into driving slowly and safely on our roads

JW NSB Store Committee Report – Elaine Beckett

- The store did \$23,439 in sales this summer a new record amount for the store
- Events... Fourth of July Sidewalk Sale, August Tent Sale, Illumination Night Sale
- Achieved the goal of selling almost all of our 2021 inventory
- Already planning for 2022 items and even more products to be added for anniversary coming up in 2023

<u>Membership/Volunteers Report – Rich McCarthy</u>

- This summer the association recorded 487 members compared to last vear's total of 500.
- Many members help to pay for our summer programming.
- Electronic volunteer sign-up was implemented through the NSB website.

Ron noted that the association bylaws need continual updating and that

- the board will be working for a full review and vote during the summer of 2022.
- Committees to write up procedures to help expedite planning.
- Develop scope for Advisory, Communications and Store committees to be added into bylaws.

- Lloyd Beckett talked openly about our rules and how they are affected by Massachusetts and local laws.
- Bill Dynan thanked the Board for taking care of the abandoned house on Arlington Street.
- A member asked about the "baby beach". Ron responded to the member that the beach is a family-owned property where we negotiate permission for the beach rights annually. Rules for this beach can be accessed on the SBIA website.
