May 25, 2024; 10:00 AM; New Silver Beach Tennis Courts

The meeting was called to order at 10:10AM. The meeting agenda is attached herein.

President Comments.

Michael Halloran welcomed all and reminded attendees that the strength of the Association is in its membership and their willingness to volunteer across numerous functions and events to make the summer a success. Michael then introduced Board members:

Mr. Halloran then reported that SBIA once again procured the services of the weekend night security team that we have used the last few years with success.

Treasurer Report:

Ron Fernandes presented the 2024 Budget and the 2023 Actual financial results. He also provided an update of the current cash position of the SBIA. A few questions were answered by Ron. Ron and Michael then discussed the Board decision to increase member dues for the first time in six years given the current financial realities of ever increasing costs.

Membership Committee:

Adam Thorpe described the distribution of the membership package and that early response has been very positive. He also discussed the distribution of beach member tags. Lastly, he discussed the NEED FOR VOLUNTEERS from all of our members in every function and event. A volunteer 'whiteboard' may be added to the beach name tag distribution tables for members to sign-up.

Grounds/Harbor Committee:

Andy Doherty noted the big beach/grounds clean up is scheduled for June 22 - many hands are needed. We have received a permit from Town for beach raking but have not been able to procure the services of a registered vendor as of yet. New signage for Baby Beach will be put in place. A new bike rack will be purchased as well as a few new picnic tables to replace worn tables. The raft and swim buoys are set to be put in place but the time of the summer beach opening June 22.

Beach Committee:

Carolyn Halloran presented, on behalf of Sarah Maxwell, that all lifeguards have been successfully hired, including two returning guards. Swim lessons for children will begin June 24 and once again beach events will include: Horribles Parade, 4th beach races, crabbing tourney and fishing tourney. Members were reminded that Baby Beach will not have lifeguard coverage and use only at your own risk - it is situated on an active boating harbor and swimming in the harbor is not advised.

Adult Activities:

Denise Foss discussed the adult events for the summer which include the opening week-end cocktail party, Illumination Night, a mid-summer themed social, and the end-of-season cook-out. Volunteers are needed for all events and please encourage others to also help out.

Michael Halloran mentioned the following adult activities will also take place: bootcamp, PoundFit, pickleball, corn hole, and the golf tourney.

Kids Activities & Events:

Kelly Strain detailed a full slate of numerous activities for member children and grandchildren - all of which can be accessed on the SBIA summer calendar on our website. The tie-dye event and the Amazing Race events are expected to be particularly well attended.

Movie Committee:

Adam Thorpe discussed the summer movie season for Sunday nights at the NSB tennis courts. He provided a tentative list of all dates and movie titles that are currently planned. Weekly reminders will go our to members in advance of the showings.

JW NSB Store:

Michael Halloran, as proxy for Casey Quirk, discussed the plans for the NSB store. Specifically, he stated on her behalf: store is scheduled to open the week of the beach opening and run at essentially the same hours as last year (both are dependent on the number of volunteers we have and the hours they can work), inventory has been purchased and should arrive soon (includes many new colors, themes and designs).

A brief Q&A was encouraged and speeding in NSB environs was the primary topic. Member Bill Dynan provided and update of discussions with the Town on this topic.
